For years, Bryce Daby and Gust Lewis watched kids cruise by with the freedom that comes so easily for so many, and they dreamed. The boys, best friends from Buhl and Mountain Iron, had long dealt with neurological disorders affecting everything from muscle coordination to speech. Surgeries and seizures didn't stop them from enjoying things like video games and music, school and the great outdoors. But they were resigned to the idea that maybe bikes weren't meant for kids with cerebral palsy.

Their parents tried to help. By building special tricycles or persuading the boys that using a walker to get around was just like biking. But it didn't work. Nothing did. Then they learned of the AmTryke® therapeutic tricycle, and they saw the possibilities. But the tricycles came with a price tag neither family could afford—until they discovered Miller-Dwan Foundation and its Abilities First Fund. It made each boy's 9th birthday especially memorable. Families watched with tears in their eyes as the boys started pedaling. And pedaling. And pedaling.

“This is the only ‘fun’ thing Bryce has been able to do, immediately, since birth. We put him on the bike and he just started pedaling. To see him ride has brought hope. And we have all of you to thank,” Amy Daby says. **“The possibility of riding a bike was just a dream to these children. You made it real.”** Using the bikes has fostered leg and torso strength that's helped the boys learn to stand and walk better than ever before. It's inspired feelings that they, like other kids, can simply get on a bike and go. **“You'll never know how much your kindness and generosity means to us,”** says Gust's mom, Deborah. **“And to a little man who'd give you the world if he could.”**

Reaching for the world

It took time for Cindy Jamnick to accept that her son had a problem. She wasn't the only one. From a very early age, Cory Jamnick faced the daunting task of trying to understand how to deal with ADHD, Tourette's and trichotilomania. It meant nervous tics, sometimes as many as 60 per minute. Or hair pulling as a stress response and leaving bald spots. It was hard enough feeling socially outcast by peers. But it was even harder when, as a new kid in school, the teacher isolated him for what she saw as "bad" behavior.

Thankfully, Cory and Cindy found support and started seeing a way out. With the aid of medicine, therapists, faith and a desire to learn as much as possible, Cory developed coping skills. Today, he's a 14-year-old with an eye for good books, a knack for computer programming, and a sense of humor about the quirks life throws him.

"It helps to laugh at yourself," he says. "Imagine looking at yourself from a third-person perspective. Seriously, if I could sit across the room and watch myself twitch, I would probably laugh at myself. That's one way I deal with it." Another way has been to advocate for better understanding. "There are resources that can help," Cindy says. "For anyone going through this, my advice is to realize you're not alone."

One of the few resources in Minnesota for helping kids like Cory is right here in our region—the child and adolescent behavioral health services at Miller-Dwan and SMDC. Last year alone, more than 3,000 young people were helped. Thanks to the generous support of the Miller-Dwan Foundation, children and families have more opportunities to achieve their greatest potential.

Jean Whiting was an early catalyst for creating the region's first residential hospice house. The touch she extended continues to reverberate. Last year, as a Solvay Hospice House patient, Jean experienced the tranquil setting she helped make possible through her visionary philanthropy. "It was perfect beauty. It's a place that offers more than dignity for the dying, but a grace-filled passage," says her daughter, Sue Ragan of Solvay Hospice House.

Despite a stroke that challenged her ability to speak or eat, Jean shared songs, celebrations and other moments made for smiles at Solvay. Like the simple pleasure of one last luxurious hot bath. Or the chance to cradle her infant grandson for the first time. "My faith was so full because of Solvay," Sue says. "There's no tension, no one telling you to leave the room. There's a serenity that I haven't felt anyplace else—a profound respect for the patient, for the family, for the spirit of those who have died."

Sue appreciated seeing the tranquility in her mother's eyes that came from peaceful surroundings and a lack of medical intervention—a stark contrast to memories of her grandmother dying in a hospital. It's one reason she and her husband, Charlie, honored Jean by helping establish the Solvay Hospice House Endowment Fund in her memory. Their donation will make it possible for so many other families to find the dignity of dying in peace.

"We wanted to honor and perpetuate my mother's vision by getting the Endowment started. Not only so the building would be taken care of, but so that patients who aren't as fortunate would have the gift of dying in great peace as Mother did. We want to make that available to everyone, and I hope other people feel the same and will help the Endowment grow," Sue says. "When death comes naturally, let it go beautifully."

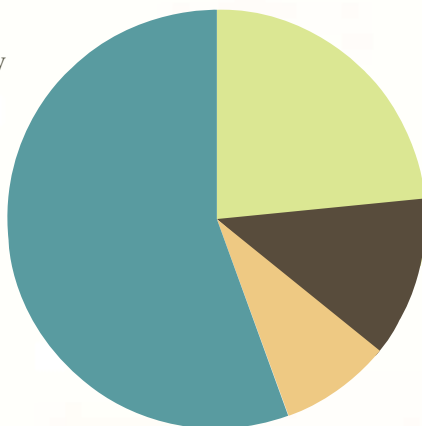

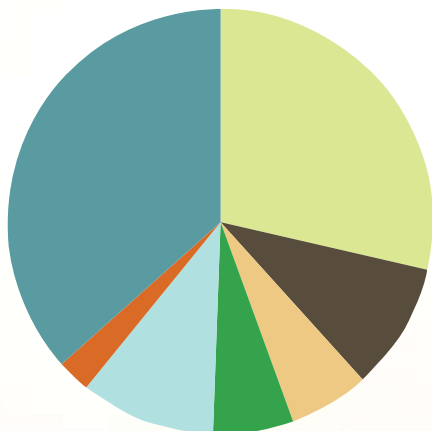
